Among other major economic initiatives, and in addition to his ongoing oversight responsibilities for the city, he led the issuance and refinancing of more than \$15.5 billion in tax-exempt and \$2.3 billion in taxable bonds, including more than \$3.2 billion in conduit financing. In addition to his experience as an elected official for one of the nation's largest cities, he has also served an in in-house attorney, a C-suite-level executive, and opened his own firm. He is able to use this experience to provide his clients with a wide array of legal counsel on public-private partnerships, public and project finance, securities, economic development, corporate governance and compliance, infrastructure, debt restructuring, government relations, and similar matters.

Ronald has experience representing clients from almost every sector.
