Commercial Litigation

- Prosecuted breach of contract and warranty claims on behalf of a global engineering and construction company against one of the world's largest compressor manufacturers in a lawsuit arising from a compressor failure at an ammonia plant.
- Successfully assisted major valve manufacturing company avoid needless litigation concerning a large commission agreement arising from a Residue Upgradation Facility construction project located in India. Drake's pre-litigation strategy and knowledge resulted in a favorable outcome, while avoiding the costs of litigation.

Energy Litigation

Trade Secret and Employment Litigation

- Defended against trade secret claims made by one of the world's largest bulk container companies against two former employees who left to join a competitor in the packaging industry. Lawsuit alleged, among other things, that the two employees absconded with trade secret information as part of a conspiracy to retain competitive business information. Lawsuit was resolved with an extremely favorable settlement for the two employees.
- Defended major bulk container company against claims made by a distributor company alleging breach
 of contract arising out of a non-existent distributorship agreement. Litigation involved unique
 contractual and fiduciary duty issues arising from prior employee's actions.
