### Oilfield Litigation

- Represented owner of oil and gas lease where neighboring operator drilled multiple horizontal wells through client's acreage. Obtained favorable settlement for client.
- Represented non-operating working interest owner in dispute where operating working interest owner claimed that client had failed to consent to the drilling of certain wells and therefore had limited interest in wells. ### **Class Action Defense**
